Dear Mr. Saccato:

This letter completes our response to your four Freedom of Information Act (FOIA) request numbers listed above. Since your requests all dealt with the same subject, we have aggregated our responses into this single response letter. Your FOIA requests asked for the following items:

FOIA request OR-2016-036, eFTS No. BLM-2016-00277, dated January 19, 2016 and received by the Bureau of Land Management (BLM) Oregon State Office on January 22, 2016, sought the "Office of Personnel Management (OPM) Standard Form 61 (SF-61), Appointment Affidavits, executed by Chad Rott, Lisa Megargee, Lance Okeson, Joe Glascock, Karla Bird, Brett Dunten, Dyan Hussey and Thomas Dyer, BLM District Manager as presently employed by Bureau of Land Management..."

You also clarified in an email dated January 27, 2016 that the record requested was actually for a "Ryan Hussey" and not a "Dyan Hussey" as mentioned in the original request.

2. FOIA request OR-2016-043, eFTS No. BLM-2016-00339, dated February 6, 2016 and received by the Bureau of Land Management (BLM) Oregon State Office February 10, 2016, sought the "Office of Personnel Management (OPM) Standard Form 61 (SF-61), Appointment Affidavit, executed by Beverly Stubbs, as presently employed as a personnel Asst. As indicated on Mr. Brent Lee Grasty's SF-61 Appointment Affidavit."

You also requested a "...a copy of the delegation of authority to Ms. Stubbs to qualify her to administer the oath..."

- 3. FOIA request OR-2016-053, eFTS No. BLM-2016-00377, to the US Fish and Wildlife Service dated February 23, 2016, was referred to the Bureau of Land Management (BLM) Oregon State Office and was received February 26, 2016. This request sought a copy of an "Office of Personnel Management ("OPM") Standard Form 61 ("SF-61") APPOINTMENT AFFIDAVIT executed by Forest Cameron by the BLM. Andrew Resource/Steens Area…"
- 4. FOIA request OR-2016-059, eFTS No. BLM-2016-00417, dated February 23, 2016 and received by the Bureau of Land Management (BLM) Oregon State Office March 7, 2016, sought:
 - a. A copy of an "Office of Personnel Management ("OPM") Standard Form 61 ("SF-61") APPOINTMENT AFFIDAVIT executed by Rick Roy, Area Resource Manager Malheur National Wildlife Refuge..."
 - b. A copy of an "Office of Personnel Management ("OPM") Standard Form 61 ("SF-61") APPOINTMENT AFFIDAVIT executed by Rick Roy, Law Enforcement Officer Malheur National Wildlife Refuge..."
 - c. A copy of an "Office of Personnel Management ("OPM") Standard Form 61 ("SF-61") APPOINTMENT AFFIDAVIT executed by Mike Green, Malheur National Wildlife Refuge..."

A search for all of the requested SF-61 Appointment Affidavits was conducted and resulted in a number of responsive records. Responsive SF-61 Appointment Affidavits are being withheld under Exemption 7(F) of the FOIA, 5 U.S.C. § 552(b)(7)(F), which permits an agency to protect from disclosure those records that "could reasonably be expected to endanger the life or physical safety of any individual." The BLM determined that release of these records would reasonably be expected to expose individuals identified in the documents to a risk of harm, e.g., stalking, threats, risk to physical safety, and/or harassment.

After a thorough search of agency records, we were unable to locate the remaining SF-61 Appointment Affidavits which are responsive to your request. Since we were unable to locate these SF-61 Appointment Affidavits, we are unable to comply with portions of your requests and are returning all the requests to you.

In response to FOIA OR-2016-043, eFTS No. BLM-2016-00339, in which you asked for the copy of the delegation of authority which qualified Beverly Stubbs to administer the oath of office, the BLM considered the date in which Ms. Stubbs signed the SF-61 Appointment Affidavit (1992) and the location where the document was signed (Vale District). The Oregon State Office and the Vale District Office searched for a delegation of authority that would have been valid during the time period in which the document was signed. After a thorough search of agency records, we were unable to locate records responsive to this portion of your request.

The person responsible for this partial denial of your request is the undersigned in consultation with Geoffrey Painter, Attorney, Department of the Interior, Office of the Solicitor, Pacific Northwest Region. In accordance with 43 CFR §§ 2.57(a)(1) and 2.57 (a)(3), you may appeal this partial denial and partial "no records" response to the FOIA Appeals Officer. The FOIA Appeals Officer must receive your FOIA appeal no later than 30 workdays from the date of this final letter responding to your request. Appeals arriving or delivered after 5 p.m. E.T., Monday through Friday, will be deemed received on the next workday. Your appeal must be in writing and addressed to:

You must include with your appeal copies of all correspondence between you and the BLM concerning your FOIA request, including a copy of your original FOIA request and this denial letter. Failure to include this documentation with your appeal will result in the Department of the Interior's rejection of your appeal. The appeal should be marked, both on the envelope and the face of the letter, with the legend "FREEDOM OF INFORMATION ACT APPEAL." Your letter should include, in as much detail as possible, any reason(s) you believe the BLM's response to be in error.

To ensure the timely receipt of your appeal, it is recommended that you fax a copy of your notice of appeal to the FOIA Appeals Officer at 202-208-6677. The FOIA Appeals Officer may be reached at 202-208-5339.

As an alternative or in addition to submitting an appeal, you can also contact the Office of Government Information Services (OGIS), which was created to offer mediation services to resolve disputes between FOIA requesters and Federal agencies. OGIS offers a non-exclusive alternative to filing an appeal, which does not affect your appeal rights as set forth in the above paragraphs. The inclusion of the following statement is mandatory for <u>all</u> BLM FOIA response letters pertaining to records: For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c) (2006 & Supp. IV (2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

The costs incurred for the processing of your request totaled under the \$50 minimum threshold. Therefore, there was no fee charged in the processing of your request. (43 CFR § 2.49(a)(1))
