— SUMMARY ALLEGATIONS —

Respondent Harris has corruptly concealed evidence of his Federal credentials for at least six (6) full years, in violation of the Federal criminal statute at 18 U.S.C. 1519, and has now been formally charged with said violation in a VERIFIED CRIMINAL COMPLAINT, ON INFORMATION filed by Relator at the U.S. District Court in Cheyenne, Wyoming ("USDC/DWY").

Respondents Crafts and Murray have aided and abetted said violation in a multitude of ways, including but not limited to serious crimes against Relator, to wit:

- (a) false arrest, by means of "sewer service";
- (b) unlawful incarceration;
- (c) cruel and unusual punishment, "diet therapy";
- (d) denial of effective assistance of Counsel;
- (e) impersonating officers of the United States;
- (f) entering a Federal Grand Jury room, and conducting "hearings," without credentials;
- (g) selecting, and summoning, Federal juries without authority, ultra vires;
- (h) failing to maintain Federal court records required by law (5 U.S.C. 2906);
- (i) violating 28 U.S.C. 1691 repeatedly in Relator's case # 2:14-CR-00027-NDF-2; and
- (j) conspiring to engage in a pattern of racketeering activities. See 18 U.S.C. 1962(d).

— PRELIMINARY REMEDIES —

- (1) PRELIMINARY INJUNCTION barring removal into any Federal court(s);
- (2) ORDER to "stand-by" Counsel, Mr. Mark Hardee, Zee and Hardee Law Offices in Cheyenne, to file promptly all docket records of #2:14-CR-00027-NDF-2 supra into the official records of this honorable Court;
- (3) ORDER immediately releasing Relator to un fettered liberty, supervised by Mr. Hardee supra until Relator safely reaches his private apartment in Seattle, Washington State;
- (4) ORDER to Mr. Hardee supra to purchase travel clothes and transportation for Relator to travel BEST WAY to his private apartment in Seattle, Wash.;
- (5) ORDER authorizing Zee and Hardee Law Offices to commence Civil RICO proceedings in this Court pursuant to 18 U.S.C. 1964 and Tafflin v. Levitt;
- (6) ORDER authorizing Zee and Hardee supra to INVOICE the State of Nebraska for full reimbursement of all time and expenses incurred in this case;
- (7) PROTECTIVE ORDER enjoining all named and unnamed Respondents from any further contact with Relator during all proceedings in this case;

(8) ORDER authorizing service of a "courtesy copy" of all actions and notices in this case upon the law firm of Fleener & Van in Cheyenne, Wyoming; and,

(9) ORDER to the Clerk of this Court to serve a copy of this Petition upon:

(b) Fleener & Van Law Offices, Cheyenne;

(c) Stephan Harris, % U.S. District Court in Cheyenne, Wyoming;

(e) Z. Robert Murray % Office of U.S. Attorney in Cheyenne; and

(f) Relator % S. B. C. D. C. (see page 1).
