2. **OATH OF OFFICE** executed by Ms. Lois G. Lerner upon occupying the position of Special Assistant to the United States Attorney for the Eastern District of Virginia (cf. same attached letter). See U.S. v. Pignatiello and 28 U.S.C. 543, 544.

I request a waiver of all fees for this request.

Disclosure of the requested information to Me is in the public interest, because it is likely to contribute *significantly* to public understanding of the operations and activities of the federal government, and is not *primarily* in My commercial interest.
