27 Section 6067 of the California Business and Professions Code reads as
28 follows:

30 Every person on his admission shall take an oath to support the
31 Constitution of the United States and the Constitution of the
32 State of California, and faithfully to discharge the duties of
33 any attorney at law to the best of his knowledge and ability. **A**
34 **certificate of the oath shall be indorsed upon his license.**

39 **DEMAND**

41 Formal DEMAND is hereby made of you to deliver a true and correct copy
42 of said certificate of oath and license to the mailing location as
43 shown below, no later than 5:00 p.m. on Monday, February 20, 2017 A.D.
44 (approximately ten (10) days hence).

46 Failure to perform will give us probable cause to charge you with
47 violating Sections 6126 and 6128 of the California Business and
48 Professions Code (both misdemeanors). See also 4 U.S.C. 101
49 ("judicial officer of a State") *in pari materia* with the Article VI,
50 Clause 3 and the Supremacy Clause (Constitution, Laws and Treaties of
51 the United States are all supreme Law of the Land).
